CCP Application **Process & Orientation**





Application Process

- Required materials
 - CCP Application
 - ACT/SAT scores
 - Official HS transcripts
 - All HS transcripts should have SSID listed per ODE
 - Students legal name
 - CCP Permission Form
 - Signed by student and parent

Deadlines

- Summer April 1st
- Fall May 1st
- Spring Oct 1st

Mandatory Orientation

- Orientation Dates
 - Spring 2020 December 13th
 - Summer 2020 April 29th
 - Fall 2020 July 27th July 30th and August $3^{\text{rd}} 5^{\text{th}}$
 - Online and On-campus required
 - Regardless of location of class all new students must complete both the online orientation AND the oncampus orientation. Returning CCP students must complete online orientation and schedule an advising appointment.
 - Registration Hold on student account until complete
 - Waivers applied manually

CCP Information Night Presentations

- All high schools must provide a CCP information session to students and parents regarding the CCP program
 - Attendance is **not mandatory** for College Credit Plus program participation
 - High schools <u>cannot</u> make attendance at the meeting a mandatory requirement
- High schools MUST provide counseling services to students and parents and BOTH student and parent MUST sign acknowledging they received the counseling prior to CCP participation
 - High school must allow parent and student to schedule an alternative time for receipt of required counseling

Dual Enrollment

Dual Enrollment Instructor Credentials

- A Master's Degree in content area
- A Master's Degree plus 18 hours in content area
- Applying to KSU to become an adjunct for Dual Enrollment
 - Application
 - Resume or C/V
 - Three letters of Recommendation
 - Undergraduate and Graduate transcripts

Dual Enrollment Courses

- All students must apply to CCP and be accepted in order to earn credit
 - Remind parents and students there are two registrations; HS and College
- All students must complete orientation requirement before course enrollment
- All students must meet college course prerequisites to take a course(s) for CCP credit
- May have students in class that are not taking it for CCP credit, however, both student and parent need to be notified prior to the course starting
- Class rosters should be sent ASAP
