YEAR 1: Education and Training (1 class period of the day) *FCCLA*

YEAR 2: Early Childhood Education I and Teaching I (2 class periods of the day) *FTA and FCCLA*

YEAR 3: Early Childhood Education II and Teaching II (2 class periods of the day) *FTA and FCCLA*

Students who are **YEAR 2 and YEAR 3** are required to provide their own transportation during two periods of the school day to an on-site school/learning facility. There is a 3-4 year-old learning facility on the campus of the ACTC on Monday, Tuesday, and Fridays from 8:15am-12:30pm.

Education and Training (460009)

Fee: \$25.....Grades: 10-11th

A one-credit course and the prerequisite for all pathways included in the Education and Training cluster. The course is designed for students who are interested in pursuing careers in education.

Early Childhood Education I (460013)

Fee: \$25.....Grades: 11-12th

A one-credit course. The prerequisite for this course is Education and Training. Course content is designed to help students learn ways to direct and operate an early childhood education program

PREREQUISITE: Education and Training and access to transportation

Early Childhood Education II (460014)

Fee: \$25.....Grades: 12th

A one-credit course. The prerequisite for this course is Early Childhood Education I. The course provides students with advanced knowledge and skills used in the field of education.

PREREQUISITE: Early Childhood Education I and access to transportation

Teaching I (460011)

Fee: \$25.....Grades: 11-12th

A one-credit course and the prerequisite for this course is Education and Training. Content includes information to help students implement the teaching and learning processes.

PREREQUISITE: Education and Training and access to transportation

Teaching II (460012)

Fee: \$25.....Grades: 12th

A one-credit course. Content provides students with advanced knowledge and skills used in the education field.
