<p>The state and local shares of the At-Risk payment will be used to support approved programs for students who are educationally at-risk in fiscal year 2022 and that a local match of funds will be provided in fiscal year 2022 based on the composite index of local ability-to-pay. In order to receive the state At-Risk payment, local school divisions are required to spend the established At-Risk payment (state and local share based on the composite index of local ability-to-pay) on approved programs for students who are educationally at-risk. These programs may include: Dropout Prevention, community and school-based truancy officer programs, Advancement Via Individual Determination (AVID), Project Discovery, Reading Recovery, programs for students who speak English as a second language, hiring additional school counselors, testing coordinators, and licensed behavior analysts, or programs related to increasing the success of disadvantaged students in completing a high school degree and providing opportunities to encourage further education and training. A local match of funds based on the composite index of local ability-to-pay is also required. Actual uses of these funds shall be collected through Schedule Q of the ASRFIN that is due every 15th of September. The Department shall compile the responses and provide them to the Chairmen of House Appropriations and Senate Finance Committees no later than the first day of each Regular General Assembly Session.</p>

<p>The division is certifying that an additional local appropriation is required to meet Required Local Match for this program for fiscal year 2022 based on the composite index of local ability-to-pay in order to receive state share funding. Further, the locality in which the school division is located shall appropriate these funds solely for educational purposes and shall not use such funds to reduce total local operating expenditures for public education below the amount expended by the locality for such purposes in the year upon which the 2018-20 biennial Standards of Quality expenditure data were based; provided however that no locality shall be required to maintain a per-pupil expenditure which is greater than the per pupil amount expended by the locality for such purposes in the year upon which the 2018-20 biennial Standards of Quality expenditure data were based. School divisions are permitted to spend such funds on both recurring (no more than 70% in FY 2021 and no more than 60% in FY 2022) and nonrecurring (at least 30% in FY 2021 and at least 40% in FY 2022) expenses in a manner that best supports the needs of the school divisions. Any unexpended lottery funds as of June 30, 2021, and June 30, 2022, shall be carried on the books of the locality to be appropriated to the school division in the following year.</p>

<p>The division is certifying to the Department that a salary increase at least an average of 2.0 percent has been or will have been provided during the 2020-2022 biennium to instructional and support personnel, pursuant to Item 145 C.44, Chapter 552, 2021 Special Session I General Assembly. Please note that the state share of funding shall be prorated for school divisions that provide less than an average 5.0 percent salary increase during the biennium; however, to access these funds, a school division must provide at least an average 2.0 percent salary increase during the biennium to instructional and support personnel. The state funds for which the division is eligible to receive shall be matched by the local government, based on the composite index of local ability-to-pay, which shall be calculated using an effective date of July 1, 2021, as the basis for the local match requirement for both funded SOQ instructional and support positions.</p>
