

Rhea County Schools Pre-K FAQ



Why is Pre-K important?

According to the Tennessee Department of Education, the human brain develops more rapidly between birth and age five than during any other subsequent period. The first five years of life are a time of enormous social-emotional, physical and cognitive growth. These early years provide a window of opportunity to set either a sturdy or fragile stage for what follows. A child's ability to be attentive, focused and follow directions emerges in the early years. Structured early learning fosters these abilities for later success in school and life.

Who is eligible for Rhea County Pre-K?

Children who turn **4 years old** on or before **August 15, 2020** who qualify for economically disadvantaged per Income Eligible application and income guidelines set by the U.S. Department of Health and Human Services.

Where are Pre-K classes located?

Pre-K classes are located at Graysville Elementary School, Rhea Central Elementary School, and Spring City Elementary School. Pre K aged children zoned for Frazier Elementary School may register at GES or RCES.

What documents are needed for registration?

*Application to determine income eligibility for the Voluntary Pre-K Program

*Application for Pre-K from Rhea County Schools

Copy of child's Birth Certificate or Hospital Record

Copy of child's Social Security Card

TN Certificate of Immunization and School Entry Medical Examination Form

Proof of Residency in Rhea County (utility statements)

Proof of Income (check stubs, W-2 forms, tax returns, SNAP number)

Custody Papers (if applicable)

What will my child's Pre-K schedule be?

Pre-K follows the same calendar as all other Rhea County Schools. The hours for Pre-K are daily from 8:00 a.m. to 1:30 p.m. Children may participate in the Rhea County School Nutrition Program and eat breakfast and lunch at school.

What will my child learn?

To align with the K-12 Tennessee Academic Standards recently adopted by the State Board of Education, the Office of Early Learning has revised the Tennessee Early Childhood Education Early Learning Developmental Standards (TN-ELDS) for four-year-olds. While there have been no significant revisions to the content of the standards, the department has worked to ensure consistent language and vertical alignment with the K-12 standards. The Tennessee Early Childhood Standards include Speech and Language Development, Early Literacy, Math and Science, Social Studies, Creative Arts, Social and Emotional Development, and Physical Development. What is the attendance policy for Pre-K?

Attendance is a key factor in student achievement, therefore, the Rhea County Board of Education adopted an attendance policy to express that students are expected to be present at school when it is in session.
