Additional Notes:

- **On-Demand Lessons** will no longer be available after October 13th. If you do not have reliable Wifi, you are encouraged to consider In-Person instruction.
- Parent selections of in-person or virtual will be maintained throughout the remainder of the semester. **Students will not be allowed to switch.**
- Virtual Learning students will log in during their scheduled time according to the schedule above. **STUDENTS MUST ACTIVELY PARTICIPATE IN THE CLASS VIRTUALLY TO RECEIVE CREDIT.**
- Students will keep their assigned iPads to continue the learning as implemented through MS Teams.
- Breakfast & Lunch will be provided for QCS students. Virtual students may opt to have meals delivered to their home or picked up at the school.
- All students and staff will be required to wear a mask while on campus. Students will be given opportunities for outdoor “mask breaks” throughout the day.
- Temperature checks and screening will be conducted daily for students and staff.
- Class size limits will be enforced for physical distancing in the classroom.
- School bus routes will be modified for physical distancing. Details will be shared once selection forms are received. We are encouraging all parents, who are able, to allow their child to be a car rider.
