Mrs. Cohen has concerns with what data is collected by student surveys. Discussion ensued, with audience participation, on what surveys are currently happening in our schools. We do not allow a third party or vendor to come in and do a survey, per our IT agreement. We still have to do an annual notification per statute. Mrs. Miner will look at what annual notification will look like and possibility of putting policy on back of notification. Mrs. Navaretta suggested that this item be tabled at the board meeting.
