#### **Financial Highlights**

Key financial highlights are as follows:

- ATDA has a total of \$174,560.80 in negative fund balance among 10 funds through June. Requests for Reimbursement for 3<sup>rd</sup> Quarter as well as Final FY21 RfRs have been requested.
- ATDA spent 84% of its Operational budget.
- ATDA has the necessary minimum cash reserve to maintain acceptable liquidity coming into FY2020-2021 and will have enough cash going into FY2021-2022 as well.



#### **Overview of Financial Position and Operations**


#### **Balance Sheet:**

Albuquerque Talent Development Academy's only bank account reports the balance by fund totaling \$1,054,148.87 as of June 30, 2021. The Operational fund currently possesses approximately 41% of the cash of the school's funds.




There are currently nine different liability accounts of which the largest are ERB and Accrued Salaries, both at 34% each. The total amounts for the liability balance is \$134,967.02.



#### **Income Statement:**

Albuquerque Talent Development Academy is heavily dependent on revenue from the Operational fund, which accounts for 81% of total revenues received as of June 30, 2021.





The majority of the expenditures were spent from the Operational fund at 82%. We cannot spend HB-33 until we are in Lease-Purchase Agreement.



#### **Expenditure Analytical Review**

There was a \$256,755 increase in ATDA's monthly expenditures over last year's total monthly expenditures for June. Keep in mind that there was a \$169,437 decrease in ATDA's monthly expenditures over last year's total monthly expenditures for May. Last fiscal year we processed all summer payrolls by May 30 in order to meet APS's RfR deadline to receive reimbursement before June 30. However, since we did not receive *any* reimbursements before June 30, this year we did not process summer payroll in May, but June as usual. Also, this fiscal year we had GEAR UP budget to spend and made several purchases to ramp that program.







