We am writing on behalf of a committee that was formed to memorialize former New Milford teacher, Lisa Cosgrove who passed away on October 27, 2019. The committee consists of teachers and members of the PTO, including parents of Lisa's former 4^{th} grade students.

The committee reflected about Lisa's characteristics and the legacy that she has left with the Sarah Noble Community. Lisa taught for 14 years and was a champion for "all students". She ensured her environment was inclusive, she nurtured the "whole child", and instilled the love of reading. Lisa had one of the largest classroom libraries for her students and was often found helping a student choose a book or facilitating a book talk. When outside at recess, Lisa enjoyed watching social interactions and engaging in conversation with students.

Outside of school, Lisa was involved in many book clubs, loved to garden, and was an active participant in community service.

The committee would like to remember Lisa by creating a library stand on the SNIS property to allow students or the community to borrow/give a book and spend time reading outside. The stand would have a small plaque with Lisa's name and a memorable quote. A bench nearby would give a place for people to sit and read or remember her.
