STEAM instructional strategies will be utilized to emphasize Science, Technology, Engineering, Arts, and Mathematics using a gradual phase in approach at the elementary and middle school levels. STEAM methodology will provide guidance to teachers as they teach the standards. Again, based on available data, Flexible Service Models may be utilized in conjunction with STEAM strategies to accelerate or remediate students as needed.
