Board Members Present

Administrator Reports

Mr. Smith reported that the year has gone well. The following retirements were recognized at the staff luncheon on Tuesday, May 17--Lowell Swisher, Eula Vaughn, Dr. David Decker, Wanda Decker, Lois Harms, and Nancy Schear along

with the following staff members leaving our district--Kelly Cady, Sandra Dulaban, and Amy Fizer. Mr. Smith also recommended having the high school gym floor refinished by Gym Masters Basketball Courts utilizing a water-based finish. Mr. Smith requested that the 15 cafeteria tables be declared surplus property as new tables have been purchased. A motion was made by Eckhoff, seconded by Parrott, to declare the cafeteria tables as surplus property and authorize Mr. Smith to advertise them for sale.

Mr. Spunaugle and Mrs. Eifert were attending the district baseball championship game, so Mr. Smith reported that the current enrollment for Grades 7-12 is 222 with an attendance rate of 94.1%. Graduation went well. He updated the board on end of the year student activities. Summer school for credit recovery began May 18. The elementary enrollment is 252. Preschool graduation is Friday evening at 6:00 p.m.
