2021 Board of Education Meeting Schedule

HOUSTON COUNTY, GA – The Houston County Board of Education approved meeting dates and locations for calendar year 2021. The Board will continue to meet regularly twice a month, with additional meetings called as needed. The purpose of the meetings is to discuss any lawful business that should come before the board.

The Board plans to continue to meet the second Tuesday of each month, with the exception of July and October. Meetings begin at 1:00 p.m. at the central office. Through June 2021, the monthly meetings will commence in the Ragin Center, unless otherwise noted. The remainder of the 2021 monthly meetings will take place in the Eric P. Staples Building, located at 1100 Main Street in Perry. Work sessions are held on the Monday evening prior to scheduled board meetings, unless that day is a holiday or in the event of a conflict such as a conference. The work sessions begin at 6:00 p.m. and take place at a district school or the central office.
