

WEBSTER COUNTY BOARD OF EDUCATION  
REGULAR MEETING MINUTES  
JUNE 10, 2019 AT 6:00 P.M.

The Webster County Board of Education held its regular scheduled meeting on June 10, 2019 at 6:00 p.m. Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, Mr. Tim Matthews, Mr. Jimmie Johnson, and Mrs. Janie S. Downer, Superintendent were present.

Mrs. Linda Rogers called the meeting to order.

Mrs. Linda Rogers gave the invocation.

Mrs. Linda Rogers recognized visitors. No comments given.

The Board approved the tentative agenda by a motion made by Mr. Donald Brown, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.

The Board approved the May 2019 financial report by a motion made by Mr. Tim Matthews, seconded by Mrs. Mary Hinman. The motion was approved unanimously.

The Board approved the May 13, 2019 (6:00 p.m.) regular meeting minutes by a motion made by Mrs. Mary Hinman, seconded by Mr. Donald Brown. The motion was approved unanimously.

The Board approved the May 28, 2019 (5:45 p.m.) public hearing minutes by a motion made by Mrs. Mary Hinman, seconded by Mr. Tim Matthews. The motion was approved unanimously.

The Board approved to change the out-of-county tuition fee from \$1200 per child/\$900 each child thereafter within a family to \$500 per child across the board and the established requirements beginning 2019-2020 school year by a motion made by Mr. Tim Matthews, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.

The Board approved fundraisers for 2019-2020 (listed on memo dated 6/10/2019) by a motion made by Mr. Donald Brown, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.

The Board approved courses without textbooks for 2019-2020 (listed on memo dated 6/10/2019) by a motion made by Mrs. Mary Hinman, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.

The Board approved the superintendent's recommendation to upgrade the camera system and communication system with the \$60,000 security grant funds by a motion made by Mr. Tim Matthews, seconded by Mr. Donald Brown. The motion was approved unanimously.

The Board approved the Final Budget for Fiscal Year 2020 by a motion made by Mr. Donald Brown, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.

The Board approved the Superintendent's recommendation to adopt the proposed paraprofessional salary schedule beginning 2019-2020 fiscal year by a motion made by a motion made by Mrs. Mary Hinman, seconded by Mr. Donald Brown. The motion was approved 4-1,

with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, and Mr. Tim Matthews voting for the motion; Mr. Jimmie Johnson abstained.

The Board approved the recommendation of the Superintendent to adjust annual salaries based on changes in duties and responsibilities beginning 2019-2020 school year (see memo dated 6-10-2019) by a motion made by Mr. Jimmie Johnson, seconded by Mr. Tim Matthews. The motion was approved unanimously.

The Board approved the recommendation of the Superintendent to change Mrs. Amanda Farr to 60% Media Specialist beginning 2019-2020 school year by a motion made by Mrs. Mary Hinman, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.

The Board approved the recommendation of the Superintendent to rehire Mrs. Marcia Roberts in the Media Center as 40% Media Specialist beginning 2019-2020 school year by a motion made by Mrs. Mary Hinman, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.

The Board approved the recommendation of the Superintendent to change Mrs. Gloria Johnson to part-time paraprofessional beginning 2019-2020 school year by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved 4-1, with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, and Mr. Tim Matthews voting for the motion; Mr. Jimmie Johnson abstained.

The Board approved the recommendation of the Superintendent to hire Ms. Shawn Muff as a substitute teacher and substitute cafeteria worker beginning 2019-2020 school year (pending completion of background check and drug screening) by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved unanimously.

Mrs. Downer presented the Superintendent's report, Special Education report, and Title I report. Mrs. Downer commented that she has completed the Pre-K budget; in the process of working on scheduling with Mrs. Swain; and Ms. Ellis and Dr. Ingram are attending an out-of-town meeting the next week. Dr. Ingram commented on the school system changing from Connexus to Apex (dual enrollment, advancement, GADOE approval) beginning September. Dr. Ingram also commented that teachers had input as well as Mrs. Downer—Apex is more beneficial to students.

The Board approved to adjourn by a motion made by Mrs. Mary Hinman, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.
