PAYMENT OF TUITION:

- Tuition Payment of \$498.80 for 2020 – 2021 school year must be remitted to the Limestone County Board of Education Central Office at 300 South Jefferson Street, Athens, AL 35611 within 10 days of receipt of acceptance letter. *Invoice from school must accompany payment.*
- Tuition is payable in cash (EXACT amount), money order, or cashier's check to Limestone County Schools. Tuition must be paid before a child is considered enrolled.
