In order to engage our community, all current families were given a survey to reflect on the Distance Learning that occurred during the Spring of 2020. This survey requested feedback on the strengths and challenges that occurred during the school closure.

Additionally, all families, teachers and board members, as well as several community volunteers were invited to attend a collaborative team meeting with the Seaside School District. Connections were made with local law enforcement, fire and emergency management, as well as the local CERT Team. Connections were also made with the local ESD and Clatsop County Public Health. All teaching staff, board members and a former PTO member participated in this event.

All new and current families were given a survey to share their feedback on which model would work best for their family. This allowed the school to choose a model that would work best for the students' diverse needs.

Cannon Beach Academy is selecting Comprehensive Distance Learning because our school resides in Clatsop County and therefore does not meet the required metrics to reopen with a Hybrid Model.

After surveying families, we found that 13% wanted a Comprehensive Distance Learning model for their student(s) and 17.4% said this option would be adequate for their family.

Cannon Beach Academy Comprehensive Distance Learning Model Overview:

Daily live/synchronous teaching for more than 50% of the school day (teacher-facilitated). We are prioritizing ELA, math and Social Emotional Learning (SEL) for the daily synchronous teaching. Synchronous teaching will be done at the same time each day to help with consistency and routine for students and families.

Daily Applied Learning for the time not spent in synchronous learning. Students will spend less than 50% of their school day participating in Applied Learning each day. All the lessons/activities students do for applied learning will be done either via Google Classroom or paper packets depending on the grade and need of the family. These lessons/activities can be done throughout the day according to a schedule the family determines.

We would like to give families consistency and routine each day, knowing we need to be flexible with the parents' work schedules and home situations.

We plan to re-evaluate to transition to a Hybrid Model on October 26 if the county metrics are met. If the county metrics are not met, we will review the metrics every 6 weeks to make a plan to transition to a Hybrid Model.
