The motion was approved 2-2 with Mr. Tim Matthews and Mrs. Mary Hinman voting for the motion; Mrs. Linda Rogers and Mr. Donald Brown abstained.

The Board approved the personnel recommendation of the Superintendent to rehire Beverly Matthews as a certified teacher (listed on the memo dated March 9, 2015) for the 2015-2016 school year by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion approved 3-1 with Mrs. Linda Rogers, Mr. Donald Brown, Mrs. Mary Hinman voting for the motion; Mr. Tim Matthews abstained.

The Board approved the personnel recommendation of the Superintendent to rehire all certified teachers (listed on the memo dated March 9, 2015) for the 2015-2016 school year by a motion made by Mr. Donald Brown, seconded by Mr. Tim Matthews. The motion was approved unanimously.

Mrs. Downer presented the Superintendent's report. Mrs. Downer also distributed the Special Education report and Title I report.

The meeting was adjourned by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved unanimously.
