3.1. Principal's Report/Student Achievement

Rationale:

Principal Robin Kelsch reported KDE is proposing changes to the current accountability system. He reported the city hired a new police officer and former State Trooper, Steven Kruger to serve as the new School Resource Officer at least three days per week throughout the day.

According to Principal Kelsch, the school district hired a third temporary position through the TENCO Workforce Development District to perform custodial and sanitation duties for the school.

3.2. Superintendent's Report

Rationale:

Superintendent Lisa McCane reported the district received a \$3,600 Durr Foundation Grant and funds will be used to purchase new graphing calculators for the middle and high school.

The district has added the Kentucky Department of Health website to the school district webpage so that parents and the public can view the daily number of active COVID-19 cases and quarantines in the school district. The district self-reports the data daily according to Superintendent McCane.

Superintendent McCane reported all state agencies, including KDE were informed to plan 8% budget cuts and the district is monitoring any possible cuts that could impact the school district.

Board members were updated the Local Planning Committee is in the process of updating the District Facilities Plan that is due June 30, 2021 to KDE. The committee will convene in January and complete the process in April during which time, will be assisted by the district's architect, Craig Aossey. The district met with Compass Municipal Advisors and will meet with RSA financial advisors before the December board meeting. Both firms are fiscal agents that assist districts with school bonds.

The Independent Auditor's Report expressed an unqualified opinion on the basic financial statements of the Augusta Independent School District. No significant deficiencies related to the audit of the financial statements were reported on Internal Control over Financial Reporting and on Compliance and other matters based on an audit of financial statements performed in accordance with government auditing standards. No instances of noncompliance material to the financial statements of the Augusta Independent School district were disclosed during the audit and no significant deficiencies relating to the audit of the major federal award programs were reported.

4.2. Approve Monthly Budget Report

Rationale:

October 2020 Budget Report

• FEMA Application Update: Finance Officer Tim Litteral reported the FEMA application for \$102,000 had been submitted on behalf of the district and that recent changes reported by FEMA may deem many of the requested expenses ineligible for reimbursement.

General Fund

Revenue receipts through October totaled over \$492,000.

Local Revenue: \$16,000 was received for utility tax. \$9,200 was collected in tuition. Nearly \$7,000 was received in motor vehicle taxes, while \$2,000 was received for delinquent property taxes and for sale of supplies. \$900 was received for a refund of prior expenditures.

State Revenue: \$453,000 was received in SEEK funding. Approximately \$2,100 was received for revenue in lieu of taxes from the state.

Federal Revenue: No federal revenue yet received.

Expenditures through October totaled \$531,000.

School Budget: The school budget is \$19,569. Through October, \$5,400 was expended. Expenses included \$2,300 on copying costs, \$1,500 for technology resources, \$1,000 on dues and fees, and \$700 on general supplies.

Maintenance Budget: Expenses totaled \$121,000 through October. Expenses included \$46,000 on property insurance, \$25,000 on salaries and benefits, \$23,000 on utility services, \$11,000 on repairs and maintenance, \$8,000 on general supplies \$4,000 in technology equipment, and \$2,000 in professional services. 41% of the maintenance budget has been utilized.

Transportation Budget: Through October, costs totaled \$29,000. The annual Suburban payment was \$11,000. \$8,000 was expended for fleet insurance, while salaries and benefits accounted for \$7,900. \$900 was expended on professional services and \$700 on diesel fuel. 29% of the transportation budget has been utilized.

For the general fund, year-to-date expenditures exceeded receipts by \$39,000.

Special Revenue Fund

Nothing to report.

Food Service Fund

Revenue: \$33,000 was received in federal reimbursement, while \$600 was received from local revenue and another \$600 was received from state revenue. Receipts totaled \$34,000 through October.

Expenditures: Expenses totaled \$44,000 through October including \$28,000 on salaries and benefits, \$12,000 on food supplies, \$3,900 on general supplies, and \$800 on dues and fees. The food service balance as of October 31 was approximately \$35,000.
