In accordance with section 18005 of the CARES Act, each LEA receiving ESSR funds shall provide equitable services in the same manner as provided under section 1117 of the ESEA of 1965 to students and teachers in non-public schools, as determined in consultation with representatives of non-public schools.

Both of the private schools have been notified of the ICP CARES funding opportunity via email with a delivery and read receipt. Both private schools declined to participate.

There are no charter schools located within Taylor County at this time.

The ultimate goal will be for students to continue to receive rigorous instruction whether in person or remote in the event of quarantines or school closures.
