RE-ORGANIZATION MEETING

Board President John Walker called the meeting to order at 6:30 p.m. in the Elementary Cafeteria. The following Board Members were present: John Walker, Rick Saffle, Curtis Crowley, Glenn Crook, Tracy Crowley, Mark Hampton and David Kearbey. Also present were Superintendent Dr. Richard Sullivan, Board Secretary Kathey Dalton, Bookkeeper Jamie Shaffer, Special Services Director Danielle Sullivan, Elementary Principal Kacie Kendrick, Middle School Principal Theresa Kearbey, High School Principal Veronica Hollis, staff members Bill Lewis, Norma Enochs and Pauletta Walker and Board members elect Johnathan Collins and James Gore.

APPROVAL OF BILLS

Trace bills # 2150 and # 2151 were approved for payment.

NEW BUSINESS

The Board accepted resignations from Mary Jo Bell as Art Teacher, Ashlyn Saffle as Para Professional, Dustie Collins as Elementary Teacher and Johnathan Collins as Substitute Bus Driver. Dr. Sullivan presented Board Members David Kearbey and Curtis Crowley with a plaque and thanked them for their service as a Board Members. Bullying was discussed.

RE-ORGANIZATION OF BOARD

Election results were presented by Dr. Richard Sullivan, the results are as follows: John Walker received 255 votes, Johnathan Collins 207 votes, Stonie Croy 125 votes, George Meyers 143 and James Gore 186 votes. Dr. Sullivan certified that John Walker, Johnathan Collins and James Gore are the elected School Board Members. The Board approved the election results. The Oath of office was administered to John Walker, Johnathan Collins and James Gore by Board Secretary Kathey Dalton. The Board voted to dissolve the current Board of Education. The Board voted unanimously for John Walker as Board President and Rick Saffle as Board Vice-President, and for John Walker and Rick Saffle to serve as MSBA Delegate and Alternative by the Board.

The Board moved to recess to Executive Session as allowed under section RSMo 610:021; 3,13 and 14 for a closed meeting to the extent authorized by law at 7:05 p.m.

EXECUTIVE SESSION

The Executive meeting was called to order by Board President John walker at 7:15 p.m. in the Central Office. The agenda was approved as presented. Laura Andrews was re-employed for the 2017-18 school year and Tom Coonce was employed as a substitute bus driver. Meeting was adjourned at 8:00 p.m.
