Purpose: To Enhance education opportunity for students

Term: 2020-2022 Golf Seasons (2-year agreement)

Team Name: Staples-Motley Cardinals

Staples-Motley Obligations:

To provide facilities, staff, program, schedule, transportation to away contests, and administration of the program (including billing the other cooperative school)

Verndale Obligations:

To provide transportation to and from practices, meets, and other activities at the Staples-Motley site for Verndale students. Pay the pro-rated golf fee structure based on the number of participants from Verndale and the total number of participants in the activity. Staples-Motley will invoice at the end of each season. Students register through Staples-Motley rSchool system.

Financial:

Each district pays the MSHSL membership fees for the activity. Each district finances its obligations as noted above. The Staples-Motley School District will add in the golf course lease agreement payment with the price per participant.

Applicable Rules & Regulations:

All policies, rules, and regulations, including the Minnesota State High School League bylaws, will be monitored and applied by the Activities Director of the school in which that students attends.

Discontinuance of Agreement:

Notice from either member district to discontinue this agreement must be filed with the other member district by December 31st of the year preceding the year of discontinuance and notification provided to the MSHSL within their time limits.
