

**CHS STUDENT PARKING
PERMIT POLICY AND
APPLICATION PACKET**

Please return the following listed below to Shane Johnson in the High School Principal's Office if your student will be driving and parking on any property or campuses of Cushing Independent School District.

- _____ Application Sheet – **FULLY** completed and signed by a parent/guardian and the student **(Pages 3&4)**
- _____ Verification of current insurance on the vehicle to bear the permit. Do not need to copy, just show when turning in application.
- _____ A valid Texas drivers' license for the student. Do not need to copy, just show when turning in application.
- _____ \$5 fee for permit. If any student has PAID for a Bearkat Paw parking space, Mrs. Raney will advise and the \$5 fee will be waived.

Student vehicles MUST properly display a current CHS parking sticker to park on campus. Any student vehicle not displaying a permit will be asked not to return to campus until a permit is acquired.

**Cushing High School
Parking Rules and Regulations**

IMPORTANT: All student vehicles parked on school property are required to properly display a current, valid CHS parking permit.

1. Parking permit must be displayed on the top left (driver) side of the FRONT windshield. Permit identification number must be clearly visible.
2. Permit must be permanently attached to the front window and not taped. Permits may NOT be shared. Parking privileges are non-transferable. Student fraudulently obtaining a permit for another student will lose all parking privileges.
3. Parking is only permitted in designated areas.
4. There will be no loitering in or around school vehicles. Students must exit their vehicle and leave the parking lot immediately upon parking.
5. Activities with the potential to cause physical body harm – clinging to or allowing other to cling to moving vehicles – is grounds for immediate suspension of parking privileges of all students involved and may result in criminal charges being filed, depending on the circumstances.
6. **No student is allowed to go to their vehicle in the parking lot during school unless permission has been granted from Mr. Gresham, Mr. Smelley, Mrs. Smith, Mrs. Davis or Mr. Johnson.**
7. All campus regulation regarding student conduct is in effect in the parking lot.
8. Any misuse of the parking permits, parking facilities, streets or drives within the control of CISD could result in forfeiture of driving privileges on school property. Examples include but are not restricted to: speeding, spinning tires, donuts, disregarding traffic signs, security personnel, CISD Police, or any other school faculty member, etc.
9. **If any CISD Administrator(s) and/or CISD Police Officer(s) has reason to believe that a vehicle may contain any element of criminal activity, the student will be asked to consent to a search of a vehicle. Failure to comply will result in the immediate suspension of the student's parking permit and privileges.**
10. Any student that drives or use the parking facilities on CISD property must have a valid Texas drivers' license.
11. **All vehicles must follow the designed flow of the parking lot and not pull through the spaces. All vehicles should pull "nose in" to the parking spaces.**

_____ I understand that any conduct constituting misuse of the parking permit, parking areas, streets or drives within the control of CISD could result in the revocation of any or all privileges bestowed by this permit.

By submitting this application, I understand, and it is my intention, to confer to any CISD Administrator(s) and/or the CISD Police Officer(s) my expressed and informed consent to search the vehicle bearing this permit while present on school property.
