INTERGOVERNMENTAL COOPERATIVE PURCHASING AGREEMENT

Cafeteria Produce Supplies

Pursuant to Chapter 39.34 of the Revised Code of Washington and to other applicable laws, the **Longview School District No 122** and **Rainier School District No 13** hereby agree to enter into a cooperative agreement for the purchase of the specified materials and/or services upon the following terms and conditions:

- 1. Longview School District No 122 and Rainier School District No 13 are duly constituted school districts and political subdivisions within the States of Washington and Oregon.
- 2. Longview School District No 122, pursuant to RCW 28A.335.190, has completed all components of the competitive bidding process for the purchase of Cafeteria Produce Supplies
- 3. Longview School District No 122, in contracting for the purchase of Cafeteria Produce Supplies for Rainier School District No 13 agrees to contract to the extent permitted by law and agreed upon by the parties during the contract period of August 17, 2019 to August 16, 2020. Rainier School District No 13 accepts responsibility for compliance with any additional or varying laws or regulations governing purchases on behalf of Rainier School District No 13.
- 4. Whenever Longview School District No 122 contracts to purchase materials or services on behalf of other political subdivisions, Rainier School District No 13 may also purchase materials or services at the same terms and conditions as Longview School District No 122. Longview School District No 122 accepts no responsibility for the performance of the vendor in any contract entered into as a result of the cooperative bid; makes no warranty, express or implied, for any materials or services acquired under this agreement; and accepts no responsibility for the payment of the contract or purchase price by the Rainier School District No 13.
- 5. Rainier School District No 13 reserves the right to contract independently for the purchase of any particular Cafeteria Produce Supplies with or without notice to Longview School District No 122.

- 6. This Agreement shall continue to be in full force and effect until the expiration date of the bid and contract. Either party may cancel this Agreement at any time prior to the expiration of the term of this bid and contract only upon written notice to the other party. The effective date of termination of the terms and conditions of this Agreement shall be fifteen (15) days from the date of receipt of notice of cancellation.
- 7. In the event this Agreement is terminated before the expiration of the terms of the Agreement, Cafeteria Produce Supplies purchased and paid for by Rainier School District No 13 shall be considered the property of the Rainier School District No 13 and the Longview School District No 122 shall have no interest therein.
- 8. Rainier School District No 13 by appropriate board action has authorized the Superintendent or his designee to execute and deliver all necessary documents to effect the terms and conditions of this Agreement.
