Parents will receive an overview of the state academic content standards, academic achievement standards, and assessments. In addition, an explanation will be given regarding Title I, what services will be offered, and how parents have the right to be involved in their child's education. Parents will learn about their role in helping their child to be successful and the best ways to work in partnership with their child's teacher. Materials to help improve their child's achievement are available to parents in the office. Training on iNOW is provided by our parent organizer.

Griggs Elementary will continue to work with its teachers through professional development, professional learning communities, data meetings, faculty meetings, and grade level meetings and planning days to help in understanding the importance of parental involvement and that parents are our partners. This year our ACIP Committee placed special emphasis on the need to ensure a closer connection between our school's identified goals and our parent involvement activities. Therefore, this year our parenting coordinator will be working with each lead teacher to ensure that grade level meetings include a parent involvement focus. The principal will set the expectation that teachers work closely with our parent organizer and Title I facilitator in planning parenting activities and purchasing materials that best meet our school's identified goals.

The team accommodated this request and made sure parents were aware all training would take place during multiple session times in order to meet parent needs.

At the present time, Griggs Elementary has 52 students classified as EL. Fifteen are ELI- 9 EL2- 34,FEL Monitored-6, FEL not monitored - 1, FLEP3, and NOMPHLOTE-2. In addition, Griggs has an EL teacher who assists in verbally communicating with these parents in their home language when feasible. If needed, our EL teacher will make sure an interpreter is provided at all Title I meetings, as well as parent conferences, to communicate with non-English speaking parents. Homeroom teachers, as well as our EL teacher, will make sure information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand. Teachers will use "Translate" in Microsoft Word to make sure information sent home is in a language the parents can understand.

Our parenting coordinator asks for parent volunteers to serve on our parenting committee to help make decisions for our school. We also have a Facebook page and a school website for parents to find information on how they can be involved at our school. We have special days, such as Fall Festival, Grits for Grandparents, a Math and Reading night, classes for parents throughout the year on various topics (Math, Reading, Technology), etc. We hold a parent meeting to inform them that they have the right to be involved in the decisions on how to use the federal funds at our school.

Our process for how all parents have the opportunity for involvement in decision-making is as follows: We have a parent involvement facilitator as well as two parent leaders who have been trained on Title I, Part A, parental involvement, and parents' rights. They keep parents informed of various committee works, and receive input from parents for committee decisions. They assist in evaluating the Parent and Family Engagement Policy, and assist in training other parents to be parent leaders. Title I parents are introduced to the parent leaders at the annual Title I meeting at the beginning of the school year.

W.C. Griggs Elementary School uses our Title I Parent and Family Engagement funds to purchase all materials and supplies for our school's summer reading program. All information is distributed and communicated to parents in a timely manner. School bulletins, classroom newsletters, school messenger, and student data reports are several ways in which W. C. Griggs provides parents with the information they need in order to keep informed of their child's education. Parents learn about priority goals in reading and math. They also learn about how o schedule parent-teacher conferences and are reminded about how they can participate in decisions related to the education of their child. If needed, our EL teacher will make sure an interpreter is provided at all Title I meetings to communicate with non-English speaking parents.

At W.C. Griggs Elementary School, all parents are given a copy of the School-Parent compact at "Meet the Teacher" night. The compact is explained to the parents, and they are asked to sign the compacts signifying their commitment to working in partnership with the school to ensure that their child is successful in school. The compacts are discussed with teachers at faculty meetings. Each teacher is given the responsibility to explain the compact to the students and obtain the student's signatures. The teachers will sign the compacts and house them in their classrooms for use during parent-teacher and/or student-teacher conferences.

In May of each year, W.C. Griggs Elementary School brings in its leadership committee to review, evaluate, and revise its Continuous Improvement Plan. There are two parents on the committee who represent the parents of the school. During the review process, all parents are notified of the review through notices sent home in our parent communication folders. The notices make parents aware that the plan is under review, that a copy of the plan is available for review in the library, on our school website, in the Parenting Center, and that parents have the right to give input regarding the revision of the plan. The notice also states that after the plan is finalized and approved, if a parent finds the plan to be unsatisfactory, they have the right to submit their concerns in writing or by emailing Melissa Cazalas, our Parent Organizer. The school will then submit their concerns to Central Office.
