Motion by Lewis DeWeese, seconded by Terry Bramlett, to approve a field trip request from Fannin County Middle School FFA to attend the Area I FFA Banquet at Chattahoochee Technical College in Acworth, GA, on May 7, 2013. All members voted yes; motion carried.

Motion by Bobby Bearden, seconded by Terry Bramlett, to go in to executive session to discuss or deliberate upon the appointment, employment, compensation, hiring, disciplinary action or dismissal, or periodic evaluation or rating of a public officer or employee or to interview applicants for the position of superintendent; (O.C.G.A. 50-14-3(b)(2)). Cynthia Panter, Associate Superintendent, reviewed the Georgia School Board Association (GSBA) outline and timeline of the upcoming Governance Team Achievement Recognition Levels. Ms. Panter explained the Board had three options for which they could apply: Quality Board, Distinguished Board, and Exemplary Board. Ms. Panter asked Board members to review these options. She will ask the Board in June to vote on which option they would like to pursue.

Karen Walton, Director of Curriculum and School Improvement, stated the Department of Education (DOE) just released 2012 grades for all K-12 public schools in Georgia based on a new measure called the Georgia College and Career Ready Performance Index (CCRPI). Mrs. Walton gave members information showing how all five schools in Fannin County performed. She explained the 2012 scores will provide a baseline for the Georgia Department of Education to assess the accuracy of the index. The DOE is expected to release additional information this fall, and the schools should receive another score before the year's end.

Mr. Henson reviewed the agenda for the meeting on Thursday, May 9, 2013.
