Approval of Board Minutes

Superintendent Ted Watson recommended approval of the January 3, 2019 Board Minutes as amended to change David Bryant to President. Upon a motion by Sammy Glover, seconded by Amy Dugger, these were approved.

Superintendent Ted Watson recommended approval of the February 19, 2019 Board Minutes as amended to include Amy Dugger as present. Upon a motion by Amy Dugger, seconded by Sammy Glover, these were approved.

Financials

Katie Odom, Chief School Financial Officer, presented the Financial Statements and Cash Balance/Bank Reconcilements for February, 2019. No action was taken.

Personnel Report

Superintendent Ted Watson recommended the approval of the following Personnel Report:

Temporary Hire

Greg Ennis, a Temporary 12th grade Government/Economics Teacher at AHS, effective March 7, 2019, through May 24, 2019.

Upon a motion by Amy Dugger, seconded by Sammy Glover, this was approved.

2019-2020 Scholastic Calendar

Superintendent Watson recommended approval of the Scholastic Calendar, Option 3. Upon a motion by David McCalman, seconded by Amy Dugger, this was approved.

4-Day Work Week

Superintendent Watson recommended approval of the summer schedule for 12 month employees beginning the week of May 27th and continuing through the last full week of July. (The First Friday observed will be May 31st and the last Friday observed will be July 26th.) The regular (5) day work week will resume on Monday, July 29th. Upon a motion by Amy Dugger, seconded by Sammy Glover, this was approved.

Lawn Care Bids

Superintendent Watson recommended approval of the lawn care bid to the primary vendor and lowest bidder, Cutting Edge Lawn Solutions (Chris Jones), with a secondary vendor, which is also the second lowest bidder, Harmony Enterprises, in case of contract cancellation. The term of the award is one year with the option to extend an additional four years at the same contract price. Upon a motion by David McCalman, seconded by Sammy Glover, this was approved.

PACA Bid Superintendent Watson presented the Purchasing Association of Central Alabama (PACA) Bid to the Board for approval. Upon a motion by Sammy Glover, seconded by David McCalman, this was approved.

Board Policy Superintendent Watson recommended approval of moving forward with the review of current board policies and developing a new board policy manual and using AASB in partnership with Bishop, Colvin, Johnson & Kent to do so. The cost would be \$12,000 with half due up front and the remainder due upon completion. Upon a motion by Sammy Glover, seconded by Amy Dugger, this was approved.

Superintendent Watson recommended to the Board the annual renewal of Section 125 Flexible Benefit Plan with American Fidelity. Upon a motion by David McCalman, seconded by Tommy Wright, this was approved.

Construction Superintendent Watson suggested contacting the City Engineer regarding the drainage issue at the football field to get ideas on how best to proceed with fixing the problem.
