### **What is the Frazier Virtual Academy?**

The Frazier Virtual Academy is online learning taught by Frazier School District Teachers. Students will have the opportunity to engage in live, virtual instructional sessions with teachers. Online learning sessions can include, but are not limited to group discussions, activities, and projects.

### **When does the Frazier Virtual Academy begin?**

During the first (4) weeks of the 2020-21 school year, all Frazier students will participate in the Frazier Virtual Academy, taught by Frazier School District Teachers. Classes will begin on August 31, 2020.

**What is the grading scale during Virtual Learning?**

Frazier School District will utilize the regular grading scale. Please refer to your child's student handbook. These are located on the district webpage.

**Will there be an Open House Event or Orientation?**

Yes, the district is working on virtual open house events for each building.

**What is the plan for students that will attend CWCTC?**

As of 7.29.2020, Frazier students accepted to CWCTC Programs will be transported to CWCTC by District transportation. Students are required to wear masks on District transportation and at CWCTC.

- Morning Session Frazier students begin instruction at 8:00 a.m. at CTC / depart from CTC at 11:00.
- Afternoon Session Frazier students begin instruction at 11:30 p.m at CTC / depart from CTC at 2:30.

**What about my child's IEP?**

Your child's case manager will be contacting you to discuss IEP Revisions for the start of the school year. Teachers and service providers will be available to provide live, virtual services. If you have additional questions, please contact Amanda Law at 724-736-9507 x 109.

**Can my child still receive school meals?**

The district is working on a plan similar to last spring to make meals available upon request.

**What if I want my child to continue with the Frazier Virtual Academy even when face-to-face instruction resumes in the school buildings?**

Parents will have the option for their child to remain in The Frazier Virtual Academy when students return for face-to-face instruction. Parents and guardians will receive a Letter of Commitment to make a determination when additional educational options become available.

**Does this plan pertain to students enrolled in the Pre-K Program?**

The district is planning to offer its Pre-K program. We are currently deciding on that platform that will best serve our students. More information will be available in the near future.
