Construction update - Geothermal project at HES should be completed by the end of the week.

• Instruction

Grades/Attendance update - after a lot of work and aligning with remote learning the average daily attendance is at 95%; chronic absenteeism has gone down after re-evaluating and understanding what does it mean to be chronically absent, we are now at 3.5%.

As far as students failing the teachers and principals have been working hard to make sure they are doing what needs to be done to make things better, earlier in the semester it was reported that the HVPS was at a 80% failing rate, now we are at 40%.

40th day data has been validated for this year and in comparison to last year we are only down 20 students, still a concern but not compared to other districts. The loss of units (students) will be made up in the Bilingual program.

• COVID 19 update

Number of positive cases in the Hatch Valley has hit a record and they will continue to increase due to availability of testing. In the District the High School Cafeteria has been hit the worse with positive cases. Rex Lish, Food Service Manager is working on opening HES and HMS Cafeterias to separate workers. This will help minimize the people exposed.
