REGULAR MEETING MINUTES  
JUNE 9, 2014 AT 6:00 P.M.

The Board approved the Class-Size Resolution for fiscal 2015 school year by a motion made by Dr. Sophronia Thompkins, seconded by Ms. LaToya Riggins. The motion was approved unanimously.

The Board approved the handbooks for Faculty, PreK-3 (Parent/Student), 4-8 (Parent/Student), 9-12 (Parent/Student), and Alternative School by a motion made by Ms. LaToya Riggins, seconded by Dr. Sophronia Thompkins. The motion was approved unanimously.

Mrs. Downer presented the Superintendent's report and the Title I report. Mr. Greene presented the Special Education report.

The Board approved the personnel recommendation of the Superintendent to accept Joshua Drew's letter of resignation as Ag Teacher by a motion made by Dr. Sophronia Thompkins, seconded by Mrs. Linda Rogers. The motion was approved 2-1, with Dr. Sophronia Thompkins and Mrs. Linda Rogers voting for the motion; Ms. LaToya Riggins abstaining.

The Board approved the personnel recommendation of the Superintendent to terminate Ronnie Crimes as a bus driver by a motion made by Mrs. Linda Rogers, seconded by Dr. Sophronia Thompkins. The motion was approved 2-1, with Mrs. Linda Rogers and Dr. Sophronia Thompkins voting for the motion; Ms. LaToya Riggins abstaining.

The Board approved to adjourn by a motion made by Ms. LaToya Riggins, seconded by Dr. Sophronia Thompkins. The motion was approved unanimously.
