# 9. PUBLIC - AGENDA/NON-AGENDA ITEMS

Susan Fean, 28 Solomon Avenue, Gibbstown, NJ, referenced the December 7, 2000 article from the Gloucester County Times and wanted to know how the Board determined which building they were going to consolidate into.

Mr. David Salvatore responded that the Board has met several times at retreats to decide which facility best met the needs of the district educationally and fiscally. He added that building costs, ADA issues, technology, and additional costs contributed to the Board's decision. He also informed Mrs. Fean that two things would happen.

- A. The public would vote and agree with the Board's decision.
- B. The public would disagree and the district will remain as it is in the present state.

Mrs. Fean then asked if the Board was aware of a report that addressed Broad St. School and its eligibility to be registered as a National Historic site.

Mr. Salvatore responded that the Board has a copy of the report and is aware of its contents.

Mr. Anthony Minniti, 80 S. Poplar St., Gibbstown, N.J., asked if the Board was aware that St. Michael's will be reopening.

Mr. Salvatore responded, "Yes, but we have not spoken with anyone from the diocese."

Mr. Minniti then commented that everybody was in one school in the early 90's and that Nehaunsey was rented out to Logan, so we should just go back to Broad St. and make the Nehaunsey School available to the Township for usage.

Mr. Marcucci responded that the Broad St. School is not conducive to today's educational needs and requirements and that people should wait to see the figures and presentation before they formulate a decision.

Mr. Minniti then added that if the Board closes Broad Street, more students would have to be bussed. Mr. Salvatore responded that the Board has taken that into consideration and he also added that the district already courtesy busses a high number of students.

Mr. Hall added that the preliminary study has helped to give the Board direction and compile an introductory set of facts and figures. He also commented that if the Board didn't take direction it would have been stumbling and spinning its wheels. It chose Nehaunsey based on acreage available and the fact that the school is more conducive to the always changing technology situation.

Mr. Salvatore commented that when you have a building that is registered on the National List, your renovations could be limited and costly.

Mr. Minniti claimed that he thought the State would provide 90% funding a project.

Mr. Combs and Mr. Hall both replied that a 40% figure was more reasonable. Mr. Hall also added that your dealing with two scenarios. Taking all things into consideration, the Board had two options. Choose an old school that is land locked and no room to grow as opposed to the Nehaunsey situation.

Mr. Salvatore added that other towns use their buildings, such as East

Greenwich, for things other than school buildings.

Mrs. Fean wanted to know why the District has been wasting money for years on two buildings them?

Mr. Salvatore replied that for years the budget did not get passed and town council told the Board to make cuts and the first place that is affected is buildings and maintenance. The Board is tired of band-aiding the buildings.

Mr. Minniti asked how many kids are in the District?

Mr. Salvatore responded between 515 and 525. Mr. Marcucci asked that the public please keep an open mind and let the Board show the facts and figures.

Mr. Salvatore added that the Board will make a public presentation.
