HONOREE: KNIGHTS OF COLUMBUS

The Damien O'Shea Hospitality Award is presented to an individual or organization who continues to make an impact in serving the needs of individuals with developmental disabilities while exemplifying the spirit of Father Damien O'Shea, the first founder and prior of St. John of God Community Services. This award is reserved for an individual or organization who has dedicated much of their life to hospitality, by doing good for others.

This year's esteemed recipient is the Knights of Columbus. With nearly 2 million members and over 16,000 local councils, the Knights of Columbus is the largest, Catholic, family, fraternal, service organization in the world. Considered the "strong right arm of the Catholic Church", the Knights of Columbus organizes and performs numerous charitable works, through the dedicated and selfless efforts of its members and their families, to help the Catholic Church, local communities, veterans, youth, and those less fortunate or vulnerable - here in New Jersey and throughout the world.

On December 7, 1965, five Hospitaller Brothers of St. John of God arrived on US soil from Ireland. Equipped with only their expertise and very few resources, they were tasked with establishing a center for the education and service of children with special needs. Immediately the Knights of Columbus committed themselves to assist the Brothers in this new work in a foreign land. The Knights could be found on any given day cleaning, building, and fundraising to make a success of the endeavors of building a school for those with disabilities. Many of the councils continue that great work of assisting us today. Individually and collectively, they continue to be a strong, trusted, and valuable friend. It is through their fundraising efforts and of course, prayers that allow us to provide those things that alleviate suffering and deepen the quality of life of those we serve. It is important to note, we continue to provide quality service to children and adults with special needs because of their faithfulness and belief in our mission.
