



Band Fees 2018-19

These fees are required for all musicians participating in Marching Band except where noted. All fees are due at Band Camp Registration which is 7/15/18 from 1-3 P.M. A separate fee schedule has been distributed for Auxiliary members. If there is an issue with payment of these fees, please contact Mr. Compton as soon as possible. Please remember we can now take Debit/ Credit Cards!

Band Camp Fee (paid by everyone): **\$100.00**
Covers cost of band camp instruction, band t-shirt and residual costs.

Uniform Fee (instrumentalists only): **\$75.00**
Covers cost of cleaning, upkeep, alteration and replacement of uniform parts.

School Owned Instrument Fee: **\$60.00**
Required for Wind Players using a school owned instrument. Covers cost of upkeep and general maintenance on school owned instruments. Ensures instruments can be cleaned professionally on a regular schedule.

Percussion (Stick and Head Fee): **\$65.00**
Required of all drumline and pit members. Covers new heads and sticks as well as general maintenance for percussion instruments.

Shoes (If Needed): **\$32.00**
Cost of band shoes.

Ticket to DCI Southern AL **\$20.00**
Completely optional. Ticket to the Drum Corps International show in Dothan AL the final night of band camp. Transportation at the student's discretion.



Student- Parent Instrument Rental Agreement

This document certifies that _____ is using an instrument that is the property of Zion Chapel High School for the _____ school year. During this time the student make take the instrument home to practice as necessary and use the instrument for any and all performances that take place during this time.
