### IMPORTANT: PLEASE READ AND SIGN

- Due to COVID-19 each student will be required to have a temperature check before being allowed on the bus. Therefore, parents you must remain at the bus stop until your child has been cleared to ride the bus. Each student and bus driver are required to wear a mask during the entire bus ride to and from school.
- If a parent/guardian is not at the bus location upon drop-off, the student(s) will remain on the bus and the school will contact the parent. Parents are expected to be at the bus stop as bringing a student back to the school is not in each bus driver's route at the end of the day.
- Students who are returned to the school 2 or more times will lose bus riding privileges for a designated amount of time.
- Please be considerate of the drop-off/pick-up locations for buses. The owners are courteous enough to allow us to use their properties for transportation locations. Do not litter or destroy property.
- Any student who misbehaves on the bus will get a warning (depending upon severity). If the behavior continues, the student may be suspended from riding the bus or permanently expelled from the bus.
