Moved, seconded, and carried to award Nelson's Farm & Garden Depot with the bid of \$2,250.00 to install existing fencing at Fannin High School.

Moved, seconded, and carried to award the West Fannin Elementary paving job to Johnson Paving, LLC in the amount of \$6,611.23.

Moved, seconded, and carried to award the Fannin High School paving job to Johnson Paving, LLC in the amount of \$45,822.83.

Moved, seconded, and carried to award the Construction Manager at Risk at Blue Ridge Elementary to Buddy Benefield Construction Company, Inc.

Moved, seconded, and carried to approve the following field trip requests:

Moved, seconded, and carried to transfer Amanda Eavenson from West Fannin Elementary to East Fannin Elementary; Janice Craig from West Fannin Elementary to Blue Ridge Elementary; Crystal Cooke from full-time teacher to a full-time Academic Coach who will devote half of her time to East Fannin Elementary and half to West Fannin Elementary; and Kristi Weeks from full-time teacher to one-half time Academic Coach in the Elementary Schools and one-half time Physical Education Teacher at Blue Ridge Elementary.
