

Page Unified School District Registration Information:

******Guardians must provide a Power of Attorney or Legal Guardianship prior to Enrollment******

Please notify the Registration Assistant prior to completing Registration process if you need assistance with obtaining this documentation. In some cases, we may already have the Power of Attorney/Legal Guardianship documentation on file.

Documents required for Registration

NEW STUDENT:

Definitions of a NEW STUDENT:

If your child has never been enrolled in a Page Unified School District School before; i.e. transferring in from out of District or out of State, your child is considered a **NEW STUDENT.

If your child was enrolled in Page PreSchool during the 20-21 SY and will be enrolling in Kindergarten, your child is a **NEW STUDENT.

If your child was previously enrolled in a school at Page Unified School District but did not complete School Year 2020-2021, your child is a **NEW STUDENT.

Documents Required for Enrolling your **NEW STUDENT**:

Birth Certificate

Immunizations – Current

Transfer/Withdrawal Grades

CIB – Certificate of Indian Blood

Withdrawal Form from Previous School

Transcript/Report Card/Progress Report

Proof of Residency (POR) – Required by the Arizona Department of Education (ADE)

Proof of Residency document must have a residential address or a physical description of the property where the student resides:

The following documents are acceptable:

- Valid AZ Driver's License, AZ Identification Car or Motor Vehicle Registration
- Real Estate Deed/Mortgage Documents/Residential Lease or Agreement
- Property Tax Bill
- Water, Electric, Gas, Cable or Phone Bill
- Bank or Credit Card Statement
- W-2 State or Payroll Stub
- Certificate of Tribal Enrollment (Title VI/506 – included in Registration Packet)

Proof of Residency – If you live in a shared residence, the owner of the residence must provide POR Documentation using one of the options above.

Proof of Residency – AZ Department of Education (ADE) Documentation Form and the Affidavit of Shared Residence will be available within the Registration Packet.

RETURNING STUDENT:

Definition of a Returning Student: If your child was enrolled and completed last school year (SY 2020-2021) – your child is a RETURNING STUDENT.

 - 3rd Grade
 - 6th Grade
