MINUTES

The called meeting of the Sumter County Board of Education was called to order by Michael Busman, Chair, with the following other members present: Meda Krenson, Rick Barnes, Alice Green, Jim Reid, and Sylvia Roland.

The called meeting agenda was unanimously approved on a motion by Ms. Alice Green; second by Mrs. Krenson. (Edith Green entered the meeting after this vote.)

A motion was made by Ms. Alice Green to approve the FY 2016 Final Millage Rate and Five Year Tax Digest; second by Mrs. Meda Krenson; motion carried unanimously.

A motion was made by Ms. Edith Green; second by Mr. Barnes to go into executive session at 6:04 p.m. to discuss or deliberate upon the appointment, employment, compensation, hiring, disciplinary action or dismissal, or periodic evaluation or rating of a public officer or employee or to interview applicants for the position of superintendent; (O.C.G.A. § 50-14-3(b)(2)); and to discuss or vote to authorize negotiations to purchase, dispose of, or lease property; authorize ordering an appraisal related to the acquisition or disposal of real estate; enter into a contract to purchase, dispose of, or lease property subject to approval in a subsequent public vote; or enter into an option to purchase, dispose of or lease real estate subject to approval in a subsequent public vote; (O.C.G.A. § 50-14-3(b)(1)). The motion carried unanimously.


