Discussion: Dr. Zila provided an update on the interview process and candidates for the position of Marketing & Communications Specialist. There were 34 applicants and 6 were chosen to be interviewed. Interviews went well, and from that group there are 2 finalists. Dr. Zila is checking background and references and will let the SAC know when a decision has been made. Further discussion centered around which districts fully support this position and will share in the financial funding. The approximate pro-rated salary will be \$45,000 through June 30, 2015 at which time the position will be re-evaluated. Districts in support are Weld RE-1, Platte Valley RE-7, and Briggsdale RE-10. Several other district Superintendents indicated they would possibly have need for this service, but could not commit up front to assist with the salary. If a district chooses to use the help of the Marketing & Communications Specialist, they will be assessed accordingly.

There being no further business, Mr. Ron Echols adjourned the meeting at 11:50 a.m.
