WHAT WE LEARNED

(*Stakeholders= Parents)

Of the 165 parents who completed and returned the results show:

- ✓ 64.42% of stakeholders prefer Class Dojo as a way of communicating school events. This is up from 56.22% in 2018.
- ✓ 84.24% of stakeholders believe Shirley Hills Elementary has high expectations for students
- ✓ 83.03% of stakeholders receive information about grade level standards and the academic requirements concerning their child's grade level.
- ✓ 90.18% of stakeholders are comfortable communicating with their child's teacher.
- ✓ 86.08% of stakeholders believe SHES offers workshops or activities that educate/inform about the curriculum and how to help improve students' success in school.
- ✓ 35.53% of stakeholders believe Reading is the subject their student struggles with Reading and 29.61% believe their child struggles most with Math.
- ✓ 54.84% of stakeholders believe they would benefit from workshops in Help with Homework and Study Skills and 33.06% say they would benefit from a workshop on the Georgia Milestones.

SURVEY QUESTIONS WITH FOLLOW-UP ANSWERS

1. I am informed in a timely manner concerning parent activities and events.
 - SHES notifies stakeholders of any activities /events through flyers, Class Dojo, the School Website, School Marquee, School Messaging Service, and emails depending on event.
2. Parent activities and workshops are offered at various times.
 - SHES schedules workshops/events at different times on various days to help accommodate parents work schedules. If parents are unable to attend a workshop they can always get the information from the Parent Resource Center, Family Engagement Coordinator (Heather Bowen), School Website (located under the Family Engagement tab), or a link is always provided on Class Dojo.
3. Parent activities and opportunities are useful and beneficial.
 - SHES plans Parent Workshops and Student/Family Events based off feedback from Parent Workshop Surveys, Parent Action Team, School Council, PTO Board Members/Participants, and the Spring Title I Parent Satisfaction Survey Results.
4. What topics do you think teachers and administrators need to discuss or learn more about to better support your family and your student be successful in school?
 - The Family Engagement Coordinator is required to conduct a minimum of four staff trainings a year concerning Parent Engagement. Parents are given the opportunity to make trainings suggestions anytime through the school website survey, workshop surveys, Parent Action Team Meetings, School Council Meetings, and the Spring Title I Parent Satisfaction Survey. Some examples of training topics for school staff could include (explaining the Compact to Parents, Texting Communications between a parent and teacher, How to include parents in Homework).
