Signet Federal Credit Union will provide a \$500 scholarship to one graduating senior from each of the high schools in our field of membership.

Student Eligibility Requirements

- Must be a high school senior attending one of the following counties high school: Ballard, Calloway, Carlisle, Crittenden, Fulton, Graves, Hickman, Livingston, Lyon, Marshall and McCracken.
- Plan to attend a two-or four-year accredited U.S. College, university or trade school in the fall of 2019.
- Must hold a GPA of at least a 3.00 unweighted (must provide copy of their transcript)
- Not an employee, child or grandchild of an employee/board member of Signet Federal Credit Union.
- **MUST HAVE A SIGNET ACCOUNT!** Students who live in our 11-county service region and are not yet members may join the credit union by opening a savings account and apply for our scholarship concurrently.

Submission Process

1. Complete the scholarship application and send copy of transcript.
2. Submit application by **March 15, 2019**.
