- School Assessments Results (report enclosed)
- Fire Marshall report (enclosed) The High School was inspected on 1/19/18 and was given a 30 working day notice to correct the noted deficiencies. However the deficiencies were not repaired. On August 5, 2019 Fire Marshall returned with a 7 day notice to repair the deficiencies, and informed the District that the school would be closed until all deficiencies were repaired. A contractor has been hired

- and will be working through the weekend to repair all deficiencies. Due to this the High School will delay opening school until August 19th.
- Cell Phones in the classroom are not allowed during instruction time as per the District handbook. All staff were advised to read the handbook.
- School Bus replacement the District received approval from PED to replace 8 school buses, approval is contingent upon quote and vendor.
- Medical Cannabis in the Schools District Nurse Moffat presented to the Board the new law regarding students possessing, storing, and administration of medical marijuana, report enclosed. A discussion was held.
- Enrollment as of today HMS-265, RGE-255, HES-174, and GES-57
- School Board Candidacy August 27th is the day to declare candidacy for School Board member if interested. Seat 2 Merlinda Hinojos, Seat 3 Lupe Castillo, and Seat 5 Greg Mitchell are up for election.
