MINUTES

The called meeting of the Sumter County Board of Education was called to order at 6:00 p.m. by Edith Ann Green, Chairman with the following other members present: Kelvin Pless, Michael Busman, Alice Green, Meda Krenson, Michael Lewis, Michael Mock, and Jeanie Smith.

A moment of silence was observed.

A motion was made by Dr. Busman, second by Ms. Alice Green to approve the agenda; motion carried unanimously.

The 2014 Final Millage Rate and Five Year Tax Digest were unanimously approved on a motion by Mr. Mock; second by Ms. Alice Green.

A motion was made at 6:07 p.m. by Dr. Busman; second by Mr. Pless to go into executive session to review an appeal from a Student Disciplinary Tribunal [Hearing Officer, Panel]; (O.C.G.A. § 20-2-757); motion carried unanimously.

After reviewing the student tribunal appeal, a motion was made at 6:40 p.m. by Dr. Busman; second by Mrs. Smith to return to open session.

A motion was made by Dr. Busman; second by Ms. Edith Green to place appellate at Ombudsman Alternative School for one year with an opportunity to return to ASHS-South with good reviews; motion carried five in favor (Dr. Busman, Ms. Edith Green, Mrs. Krenson, Mrs. Smith & Mr. Pless); three abstained (Ms. Alice Green, Mr. Michael Lewis & Mr. Michael Mock).

A motion was made at 6:42 p.m. by Mrs. Smith; second by Dr. Busman to go into executive session to discuss or deliberate upon the appointment, employment, compensation, hiring, disciplinary action or dismissal, or periodic evaluation or rating of a public officer or employee or to interview applicants for the position of superintendent; (O.C.G.A. § 50-14-3(b)(2)). The motion carried unanimously.

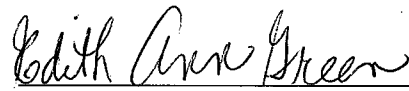
