### PRE-TRIAL DIVERSION TRUANCY AGREEMENT

- 1. I understand that I have been summoned to the Court by the Houston County Board of Education for violation of the Compulsory School Attendance Law (also known as Truancy).
- 2. I understand that Truancy has a statutory legal definition and that I will be judged as to whether my child is truant based upon that definition.
- 3. I understand that the Houston County School Board policies and procedures regarding truancy are in accordance with statutory requirements of the Official Code of Georgia.
- 4. I understand that any absence of my child for which I do not provide written documentation showing a legally acceptable justification can be considered unexcused.
- 5. I understand that I have <u>3 days</u> to provide sufficient written documentation, and that if I fail to do so the absence can be considered unexcused even if I later provided documentation showing a legally acceptable justification.
- 6. I understand that the School Board determines, in accordance with the law, what reasons are legally justifiable and that if written documentation is provided but does not show a legally justifiable reason for the absence then it can be considered an unexcused absence.
- 7. I understand as a parent/guardian that it is my responsibility to know the policies and procedures and the law concerning truancy and that I am legally accountable whether I am aware of them or not.
- 8. I understand as a parent/guardian that I can be charged with and face criminal penalties if my child is determined by the Court to be truant.
- 9. I understand the Magistrate Court Judge may review the evidence provided by the school and can make a determination that my child is legally truant.
- 10. I understand that the Magistrate Court Judge may proceed with a hearing on the matter based upon the application of the School Board if I deny that my child is truant, and may issue an arrest warrant against me if the Court finds that probable cause exists that my child is truant.

- 11. I understand the Magistrate Court Judge will allow me to handle this matter without having to appear at a Hearing if I agree to handle the matter as a Pre-Trial Diversion.
- 12. I understand that Pre-Trial Diversion requires the following:
  - a. My child must attend school daily without any unexcused absences.
  - b. I must sign a Truancy Contract if requested.
  - c. I must participate in the Project Reconnect Program, which can include, but is not limited to, classes, tutoring, community service or counseling.
  - d. I understand that the Diversion period can range from 30 to 90 days, depending on the circumstances, number of absences and my child's prior school attendance record.
- 13. I understand that if I do not agree to a Pre-Trial Diversion or if I fail to successfully complete the terms of the Pre-Trial Diversion that I may be arrested and can be prosecuted for violation of the Compulsory School Attendance Law.
- 14. I understand the Magistrate Court Judge is aware that I am being offered to the opportunity to resolve this matter as a Pre-Trial Diversion and that the Court will take into consideration whether I failed to successfully complete the Pre-trial Diversion program if I am summoned to appear in court for a hearing.

By signing this document, I hereby acknowledge that I am in violation of the Compulsory School Attendance Law and agree to have my case handled as a Pre-Trial Diversion and that I have had the above terms and conditions explained to me and I hereby understand and accept said terms.
