- 6. Student/Staff Recognition Superintendent's Report

Superintendent Schwarting noted the following:

a) Makeup School Days

As suggested by the Board, a survey was taken from the teachers regarding a makeup day for students and the results were that December 20, 2019, be the day for makeup.

- New carpet has been installed in the media center of Bamberg-Ehrhardt Middle School.
- Mulch is being replaced with a new rubberized product underneath all playground equipment at Richard Carroll Elementary School.
- The retention ponds at Richard Carroll Elementary School have been cleared and are being maintained by a new company. As a result, they now look good.
- Current Student Enrollment: 1,247 [Board Packet Enclosure]

- 7. 2019 Bamberg School District One Audit Neal Crider, McGregor & Company Board Packet Enclosure: Annual Financial Report Year Ended June 30, 2019 Mr. Neal Crider, auditor, noted that the District received a "clean opinion" on the financial statements no internal weaknesses or significant deficiencies related to internal control on financial reporting no material non-compliance. A "clean opinion" was issued on Food Service and Title I which are major programs this year. The General Fund ended with an increase in the Fund Balance of \$50,113.00 bringing the total Fund Balance for the General Fund to \$1,236,170.00. Food Service had a decrease in participation this year; therefore, \$53,911.00 was transferred from the General Fund. This program may need to be looked into in order to avoid having to transfer funds. Overall, Mr. Crider noted that this was not a bad year for the District.
- 8. **Discussion: Board Policy BID Board Member Compensation and Expenses**Following another discussion regarding the amount of money Board members in this
 District receives in comparison to some neighboring school districts, Board Chair Walker
 noted that an increase in compensation will be discussed further among Board members
 and, perhaps, be addressed at the next Board meeting. [Board Packet Enclosures]

Allison Hanna, the District's Attorney, and Superintendent Schwarting, beliefs are that in order for Board members to receive an increase in compensation, the Board would need to submit a new request (compensation) to Representative Justin Bamberg and Senator Brad Hutto, local legislators. Currently, Board members in this District are paid \$1,200.00 a year (\$100.00 per month).

9. Monthly Financial Report

Finance Director Devon Furr presented the Financial Report for October 2019, for review. Ms. Furr noted that, at this time, the replacing of mulch at Richard Carroll Elementary School is the only project that is being undertaken in the District. Also, Mrs. Furr noted that the Abbeville money has been spent and all the schools in the District received some of the funding. [Board Packet Enclosure]

Trustee Tony Duncan moved and Trustee Kim Berry seconded to accept the October 2019, Financial Report as presented. The motion passed 5-0.
