



Leland School District **SUMMER LEARNING RECOVERY, EXCEPTIONAL EDUCATION, ELL** **EDUCATION & EXTENDED SCHOOL YEAR PROGRAMS**

Summer 2020 - 2021

The online enrollment dates are May 3 -15, 2021.

Due to COVID 19 the Leland School District will offer Summer Learning Recovery to ALL students in the Leland School District. The district will offer in-person classes following the CDC guidelines to address learning recovery, credit recovery and enrichment acceleration opportunities for the students of the Leland School District. The Summer Learning Recovery Program will allow **all** students the opportunity to participate. The Leland School District Summer Learning Recovery, Exceptional Education, English Language Learner Education and Extended School Year programs (ESY) are designed for student learning recovery opportunities and Pre-K-12 promotion opportunities for Leland School District students ONLY!

The following guidelines will be used in establishing the program and for allowing or disallowing student participation:

1. Grades Pre-K- 3 (ONLY MATH , ELA) & 4th – 5th (ONLY MATH, SCIENCE, ELA) coursework requirements:
 - a. If a student is passing reading, but has failed either math or Language Arts with at least a **60 average** (but not both), she/he may attend the ESY program. A student with an average **of 60-68** must successfully complete course work on a weekly basis for the entire six week program order to receive course mastery. Any student missing an entire week of participation barring extenuating circumstances, must get approval from the program administrator in order to be granted credit for the course.

A student in grades K-6 who is passing, but whose reading level score is below grade level - falling in the minimum or basic categories or who has scored 65-75 on end-of-year grades in ELA/Reading will be recommended to attend Leland School District Learning Recovery Program for the summer of 2020 -2021. **This does not retain a child who is passing:**

- b. Kindergarten students who fail to master assigned competencies will be retained ONLY with the administrator, parent and teacher ALL agreeing. These students may enroll in the summer transition program for kindergarten for Learning Recovery.

However, if a failing kindergarten student demonstrates required mastery on the district competency test at the end of the summer program, he/she may be promoted to first grade;

- c. A student may only be enrolled in two (2) ESY courses in Pre-K through 12 grades.
- d. Pre-k through 5 grades (ONLY Math and ELA/Reading); 6 – 12 grades any 2 of the 4 courses (Math, Science, Social Studies, English).
- e. Pre-K students with an evaluation score of “Needs Improvement” (N) or “Unsatisfactory” (U) are required to attend the ESY school summer program.

2. Grades 6 -12 coursework requirements:

- a. If a student in grades 6-12 has a yearly average that is at least 60 or above, but less than 69, she/he may be eligible to attend the district’s virtual ESY program.
- b. Students may *only* be enrolled in (2) ESY courses for 6th – 12th grades (*Math, ELA, Science, Social Studies*) A student with an average of 60-68).
- c. A student cannot be enrolled in an ESY program and the summer learning school program at the same time.
- d. A student will be considered **retained** until specified deficiencies from the regular term are removed through successful completion of all prescribed coursework in the Leland School District’s ESY program.
- e. Successful completion of academic work in an ESY program will permit a student who meets all other promotion requirements to be promoted to the next grade.

Successful completion is defined as mastery of 75% of the student’s core skills, as identified on the student’s academic profile record, and acquiring a final grade of 69 for the course.

3. General guidelines and fees:

- a. The student will be expected to follow state, local, and district COVID 19 guidelines while participating in the Summer Learning Recovery Program and/or ESY program to remain and participate in the programs.
- b. Only Leland School District students will be accepted into the program.
- c. All prek-12 students attending the Summer Learning Recovery Program and ESY program will be exempted from any fees. (FREE OPPORTUNITIES)
- d. **ESY online** registration will be held on May 3 - May 15, 2021
- e. CLASSES WILL BEGIN Monday, June 7, 2021 and end Friday, July 15, 2021.

The **Exceptional Education Summer Learning Program** will be held in conjunction with the Summer Learning Recovery and ESY programs.

All teachers working the summer program will assign, monitor, evaluate and provide feedback to both student/parent on a daily basis if needed/ but is required to provide weekly progress monitoring reports to the parents and building administrators or program director.

A student schedule for assigning lessons and feedback will be established for the summer before the first day of summer instruction.

A **MINIMIUM** OF TWO LESSONS PER CONTENT AREA PER WEEK WILL BE REQUIRED A FOR A GRADE.

Teacher planning, parent & student contacts, reporting data, professional learning are embedded in the allotted 3 hours on Friday. (9 a.m. to 12 – **Telework on Friday unless staff are asked to come to the campus**)

Teachers will be compensated for 6 hours per day with time digital logs and or time sheets to be turned in each Monday to their building administrator to flow to the district office.

The number of Student/Teacher days per week will be –

Week 1	June 7 - 10	(4 days)
Week 2	June 14 -17	(4 days)
Week 3	June 21 - 25	(4 days)
Week 4	June 28 – July 2	(4 days)
Week 5	July 5 – 8	(4 days)
Week 6	July 12 - 15	(4 days)

Fridays **will be a 3 hour Telework Day, UNLESS staff are asked to report to campus for professional learning or Telework isn't working. Fridays are mainly designed for data analysis, planning, progress monitoring, and professional learning.**

The cafeterias will serve lunches following the COVID 19 Schedule currently in place at the designated sites from 11 - 12:30 at Beulah Grove, Pleasant Spring, New Zion Churches, Unity Church and Elizabeth Park until the end of the summer program unless state law says otherwise. Meals will be served Monday through Thursdays (*Thursdays meals will include Friday meals*).

Leland School District PRE-KINDERGARTEN / KINDERGARTEN TRANSITION (Leland Early Learning Institute) 2020 -2021

1. The Pre-K / Kindergarten Transition programs will be in-person following the CDC guidelines unless state guidance dictates otherwise for students who will be eligible to attend the district's kindergarten program in the fall.
2. Transition activities include:
 - Online Diagnostic assessment and age level appropriate learning activities
 - Online Social skills development
 - Online Home-school connection activities
3. **Online Registration will be held May 3 - 15, 2021 at:**

- **Leland Early Learning Institute for entering grades Pre-K and entering K**

In order to be admitted to the **Pre-K Transition program**, the child must be **FOUR** years old on or before September 1, 2021.

In order to be admitted to the **Kindergarten Transition program**, the child must be **FIVE** years old on or before September 1, 2021. Parents must present the child's immunization record, birth certificate, and social security card during registration, as well as proof of residency.

4. **CLASSES WILL BEGIN June 7, 2021 and end July 15, 2021.**

**LELAND SCHOOL DISTRICT SUMMER LEARNING RECOVERY, EXCEPTIONAL
EDUCATION, EXTENDED SCHOOL YEAR PROGRAMS
AND
PRE-KINDERGARTEN TRANSITION PROGRAMS**

The Leland School District will hold its Annual Summer Learning Recovery, Exceptional Education, Extended School Year and Pre-Kindergarten Transition Programs as mandated by law for grades Pre-K through 12th grades during the months of June and a portion of July. Registration date for the program is May 3 - May 15, 2021. Classes will begin on Monday, June 7, 2021, and conclude July 15, 2021. Leland School District students/parents may contact the principal or counselor to determine **eligibility prior to June 1, 2020.**

All children who will be entering Leland **Pre-K during the fall term must be 4 years** of age on or before September 1, 2021. Pre-kindergartners are eligible to participate in the district's summer Pre-kindergarten transition program. The program is **FREE** and will begin June 7, 2021. Classes will begin June 7, 2021 serving students *Monday through Thursday of each week.*

Again, in order to be admitted to the **Kindergarten Transition program, the child must be 5 years old on or before September 1, 2021.**

Parents are asked to bring/send a copy of the child's immunization record, birth certificate, and social security card, as well as two proofs of residency.

COVID 19 Lunch sites are Pleasant Spring Church, Beulah Grove Church, Unity Church, Public Park in Elizabeth and New Zion Churches during the hour between 11 until 12:30 on Mondays through Thursdays. Meals are prepared for the portion size to feed a child for the week. (Thursday's meals will include Friday meals).
