## PARENT CONTRACT

Grade:

The goals of NMCS are to offer its students a program of education characterized by a belief in the Christian faith, in the Bible as the inerrant Word of God, and a curriculum of academic excellence. The Parent is in accord with these goals and desires to provide his/her child with this type of formal religious/educational environment. The Parent agrees to cooperate with the administration and faculty of North Mobile Christian School and to adhere, as well as, assure that his/her child adheres to the policies and procedures outlined in the NMCS Family Handbook.

The Parent hereby enters into this contractual agreement with NMCS to pay the required fees and charges as published in the 2020-2021 Tuition and Fee Schedule on the basis of enrollment for the full school year, or that part of the school year remaining after entrance. Parent agrees that all fees are nonrefundable and that payments must be made according to fee schedule in order to maintain their child's position at NMCS. Accounts paid in full are not required to carry tuition insurance, but no portion of tuition will be refunded after the first day of school. Withdrawal of accounts paid in full carrying tuition insurance will be prorated and refunded 1/2 of the unused portion of tuition. <u>NMCS will not hold student's position if fees are not paid by their due date</u>. <u>Tuition payments are due on the 1st of each month, and a late fee of \$20.00 will be added if tuition is not paid by the 5th of the month</u>. If tuition is not paid by the 10th, the student will not be allowed to attend class until the account is no longer past due. All daycare fees are to be paid in full on Mondays. Accounts delinguent for two weeks will result in termination of daycare services.

The Parent grants permission for the student to take part in all school activities and school-sponsored trips away from the school premises, and absolves the school from liability to the parent or child because of any injury to the student at school or during any school activity. The Parent grants permission for their student's prior school to release all academic and behavior records to NMCS. NMCS admits students of any race, color, and national or ethnic origin.

All records, including report cards, will be held for <u>any</u> outstanding balances.
