**STANDARDS AND ASSESSMENT** – Fouke is hosting Structures Level 1 Training on their campus August 5-9, 2019. Other districts are invited.

Academic Reading is a credit-bearing, two-semester course for high school students that have been identified with the characteristics of Dyslexia.

Mrs. Morris shared a list of dates for the ADE Summer Assessment Professional Development and a link containing ESOL Institute information.

An alternate pathway to graduation, for students with cognitive disabilities, will be available to incoming freshmen for the 2019-2020 school year, beginning with this 9<sup>th</sup> grade cohort.

The Department of Career Education has reviewed existing CTE courses, for award of math or science credits, to meet graduation requirements. These credit options go into effect beginning in the 2019-2020 school year.

These included a bill concerning cameras in the special education classroom and proposed legislation impacting the start of the school year. Also, discussed were bills dealing with corporal punishment and vouchers.
