BOARD OF EDUCATION SOUTHERN LOCAL SCHOOL DISTRICT COLUMBIANA, CARROL AND JEFFERSON COUNTIES, OHIO

The Board of Education (the "Board") of the Southern Local School District, Columbiana, Carrol and Jefferson Counties, Ohio (the "School District"), met in a special session on July 2, 2019, at 6:00 p.m., at the offices of the Board, 38095 State Route 39, Salineville, Ohio 43945, with the following members present:

M_____ introduced the following resolution and moved its passage:

RESOLUTION DECLARING IT NECESSARY TO LEVY AN ADDITIONAL TAX IN EXCESS OF THE TEN-MILL LIMITATION

(O.R.C. Sections 5705.03, 5705.21) Permanent Improvement Levy

WHEREAS, the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the School District; and

WHEREAS, a resolution declaring the necessity of levying an additional tax levy outside the ten-mill limitation must be passed and certified to the County Auditor of Columbiana County, Ohio (the "County Auditor") in order to permit the Board to consider the levy of such a tax levy and must request that the County Auditor certify to the Board the total current tax valuation of the School District and the dollar amount of revenue that would be generated by the tax levy;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Southern Local School District, Columbiana, Carrol and Jefferson Counties, Ohio, two-thirds of all of the members elected thereto concurring, that:

Section 1. It is necessary to levy an additional tax in excess of the ten-mill limitation for the purpose of permanent improvements of the School District.

<u>Section 2</u>. The question of such an additional tax levy shall be submitted to the electors of the entire territory of the School District at the election to be held therein on November 5, 2019. All of the territory of the School District is in Columbiana, Carrol and Jefferson Counties, Ohio.

Section 3. Such additional tax levy shall be at a rate not exceeding 2.25 mills for each one dollar of valuation, which amounts to \$0.225 for each one hundred dollars of valuation, upon the entire territory of the School District, for a period of five years.

Section 4. Such additional tax levy shall be placed upon the tax list and duplicate for the 2020 tax year (commencing in 2020, first due in 2021) if a majority of the electors voting thereon vote in favor thereof.

Section 5. The Treasurer of this Board is hereby authorized and directed to certify a copy of this Resolution to the County Auditor with instructions to certify to this Board the total current tax valuation of the School District and the dollar amount of revenue that would be generated by the levy if approved by the voters of the School District.

<u>Section 6.</u> It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Ohio Revised Code Section 121.22.
