Bus Specifications for Two (2) New 2019 or 2020 30-Passenger Chevy School Buses

- Printed specifications of each bus must be enclosed/attached to the Proposal.
- > Buses must meet all requirements of the Federal Motor Vehicle Safety Standards (FMVSS) for the Chassis and the Body for 30-passenger School Buses including state and local codes.
- ➤ In addition to the FMVSS requirements, the buses *must have*:
 - o Gasoline Powered
 - o Air conditioning
 - o Electronic sleeping child monitoring system
 - o Hydraulic brakes
- ➤ It is *preferred* that the buses have:
 - o Driver side auxiliary step
 - o AM/FM/CD Player
- A Manufacturer's Certificate of Compliance is to be provided for each bus upon delivery.
- ➤ "BRADFORD-TIOGA HEAD START INC." lettering and Bus ID number will be applied to both sides of School Bus appearing in 6" black capital case letters. An 8" Bus ID number is to be applied to the front, back, and each side of bus. The numbers will be issued to the successful bidder upon the award.
