SCHOOL PLAN FOR SHARED STUDENT ACHIEVEMENT

What is Title I?

Sumter County Elementary School is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to the challenging State academic standards to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support family engagement. All Title I schools must jointly develop with parents and family members a written parent and family engagement plan.



How is it revised?

Sumter County Elementary School invited all parents to attend our annual Parent Input meeting to review and revise this parent and family engagement policy, as well as the school-wide plan, our school-parent compact, and the family engagement budget. Additionally, parent input and comments regarding this plan are welcome during the school year through an online form. The plan is posted on our school website for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey online and by mail to ask parents for their suggestions on the plan and the use of funds for family engagement. Parents and family members can also give feedback during several parent meetings and activities during the school year including our annual Stakeholders' Input Meeting.

What is it?

This is a plan that describes how Sumter County Elementary School will provide opportunities to improve family engagement to support student learning. SCES values the contributions and involvement of parents and family members to establish an equal partnership for the common goal of improving student achievement. Sumter County Elementary School will take the following measures to promote and support parents and family members as an important foundation of the school in order to strengthen the school and reach our school goals. We will:

- * Provide necessary materials and handouts for parents at conferences, meetings, and activities to help parents work with their child to improve their child's achievement.
