Calendar for the 21-22 School Year

Mrs. Almon presented the Committee with the proposed calendar for the 21-22 school year that has teachers returning for 5 days of Pre-Planning on Wednesday, July 28, 2021 for 5 days of training, and students returning for the first day of school on Wednesday, August 4, 2021. The calendar presents several teacher workdays located throughout the school year, rather than on the front and back end of the year. The school year will end for students on May 20, 2022 and on May 24, 2022 for all teachers. This calendar will be presented to the Board of Directors on Thursday, March 18, 2021 at the Board Meeting for approval.

Charter Contract Amendment

Mrs. Almon and Mr. Lee have been working on a letter to submit to SCSC staff, requesting the addition of the 10th grade for the 21-22 school year. The SCSC staff has remained firm in their stance that they will not support the Charter Amendment due to the lack of new, compelling academic data since there has been no Georgia Milestones Assessments administered since the 2018-2019 school year. The letter is anticipated to be emailed on Monday, March 15, 2021, which will be at least two weeks in advance of the SCSC Board Meeting scheduled for March 31, 2021 at 10:00 am in Atlanta.
