Dr. Gasper's Report

This school year concludes my 25th year in the profession of public education. I can confidently say that, at no time, has the profession ever been more complex, more demanding, or more stressful for employees. At present, there are innumerable details related to COVID-19 that the school and district administrators, secretaries, department directors, and I are working on. To give the Board a small window into the complexity of our current and future work, I've broken this down into near-term, mid-term, and long-term planning that is happening now.

Near-term (before July 1):

- **Retrieving Belongings:** Student and teacher belongings (including medications stored in nurses' offices) must be retrieved from desks, lockers, and offices. We will have our staff do this work with all of the necessary safety protocols in place. We'll then schedule times when individual parents or students can come to a safe location to pick up these items. This project involves administrators, teachers, custodians, and district leadership.
- **Closing Out Distance Learning:** Teachers, administrators, student services professionals, and paraprofessionals continue to engage as many students as possible in distance learning. The small number of students (5-10%) who are not engaged receive regular and frequent attempts at contact from teachers, school counselors, and administrators. Evaluating, grading, and recording all of this work is a new level of challenge for those involved.
- **Ceremonies and Graduations:** As the Board is aware, our planning for drive-thru graduations at TMS and WHS is underway. "Wave parades" will occur at the elementary schools. All of these events require a level of detail and planning. These projects involve parents, students, teachers, administrators and a myriad of other staff in support.
- **Prepare Summer School:** As you've read in my May 21st email, Summer Studies will be greatly reduced this year but this does not reduce the amount of planning that is necessary; in fact, it increases it under the State's guidelines. The Summer School Director and Assistant Director have already been working for weeks on this project with the support of our Nurse Manager, Special Education Administrators, Director of Facilities, and Assistant Superintendent.
- **Develop Multiple Contingency Plans:** the first meeting of our Schools Transition and Reopening Team (START) will occur next week. This is the group that will have broad representation and will endeavor to predict the ways in which our schools can function under new restrictions. The restrictions, of course, are a moving target for now until we get fuller clarity from the State.

Mid-term (July and August):

- **School Sanitation and Upgrades:** During July and August we'll be engaged in ensuring that all surfaces in all spaces are sanitized once again (after having done so in March/April). We will be tracking state guidance to see if plexiglass shields, ventilation changes, reformatting cafeteria serveries, etc. are required and possible for us.
- **Execute Summer School:** The limited summer school program will serve as a beta test for many of the operational changes that will be needed in the long term.
- **Policy Changes:** The Board Chairman will serve as the Board's representative on the START team. Her participation, among other facets, will help the Board be apprised of policy changes that are needed to address the pandemic.
- **Plan for Budgetary Changes:** At the moment, I am confident in our 2020-2021 budget as crafted. We can be certain, however, that there will be changes to which we need to adapt. The summer will be time for the Business Manager and me to bring these potential changes to you for your consideration.
- **Collaborate with Transportation Provider:** Depending on the guidance for reopening from the State, how and when we transport our students to school may look very, very different. The Principals, the Business Manager, and I will need to monitor this closely and ensure that we're ready.
- **Outdoor Graduation:** As I've stated, we have not given up on an outdoor graduation ceremony for WHS seniors. If the Governor lifts the maximum size of gatherings above 250, this project will have all of its usual complexity (planned by WHS staff) along with extra requirements related to COVID-19.

Long-term (Upon resuming school):

- **Plan for the Possibility of Continuing in the Distance Learning Format:** Continue to support teachers with training and tools that they request. Explore the possibility of a mixed model in which special education students with significant needs may be able to come to school periodically for their services.
- **Plan for Possibility of Alternating Schedules:** Impact on amount of curriculum taught, transportation, food service, custodial costs.
- **Plan for Ongoing Rigors of Somewhat-Normal Operation:** Implement all CDC guidelines to extent possible. Extended sanitation protocols, cafeteria operations, labor disputes, and contract changes.

I have a very strong confidence in our staff. I know that, even though these tasks are difficult and often unpleasant, we will rise to the challenge together, adapt when necessary, and serve the children of Wolcott to the highest level possible.

SUBJECT: Temporary Extension of Educator Certificates and Coaching Permits

In accordance with Governor Ned Lamont's Executive Order 7C, I am writing to provide guidance regarding the extension of educator certificates and coaching permits for educators whose ability to meet statutory and regulatory requirements may be impacted during the COVID-19 pandemic.

Effective immediately, the Bureau of Educator Standards and Certification will extend the expiration date of *all Initial and Provisional Certificates (including Interim) and 5-Year Coaching Permits with expiration dates between 3/15/20 and 12/31/20 for 1-year from the date of original expiration.*

This extension does not apply to permits and/or authorizations such as 90-Day Certificates, Long Term Substitute Authorizations, Durational Shortage Area Permits (DSAP), Charter School Educator Permits and Emergency Coaching Permits, nor does it apply to Resident Educator Certificates. Educators currently serving under any of the aforementioned permits/authorizations will be able to seek renewal at the time of expiration in accordance with existing policy and procedures.

Educators may continue to renew Professional Educator Certificates online or by mail at no cost to the applicant, in accordance with existing policy and procedures. Additionally, 5-Year Coaching Permit holders are reminded it is their professional responsibility to maintain current First Aid and CPR certifications.

Over the coming weeks, the Bureau of Educator Standards and Certification will automatically update new expiration dates within the Connecticut Educator Certification System (CECS) and will print and mail new certificates to those educators impacted by the change.



In accordance with Governor Ned Lamont's Executive Order 7C, I am writing to provide guidance regarding the extension of educator certificates and coaching permits for educators whose ability to meet statutory and regulatory requirements may be impacted during the COVID-19 pandemic.

Effective immediately, the Bureau of Educator Standards and Certification will extend the expiration date of *all Initial and Provisional Certificates (including Interim) and 5-Year Coaching Permits with expiration dates between 3/15/20 and 12/31/20 for 1-year from the date of original expiration.*

This extension does not apply to permits and/or authorizations such as 90-Day Certificates, Long Term Substitute Authorizations, Durational Shortage Area Permits (DSAP), Charter School Educator Permits and Emergency Coaching Permits, nor does it apply to Resident Educator Certificates. Educators currently serving under any of the aforementioned permits/authorizations will be able to seek renewal at the time of expiration in accordance with existing policy and procedures.

Educators may continue to renew Professional Educator Certificates online or by mail at no cost to the applicant, in accordance with existing policy and procedures. Additionally, 5-Year Coaching Permit holders are reminded it is their professional responsibility to maintain current First Aid and CPR certifications.

Over the coming weeks, the Bureau of Educator Standards and Certification will automatically update new expiration dates within the Connecticut Educator Certification System (CECS) and will print and mail new certificates to those educators impacted by the change.



SUBJECT: Temporary Extension of Educator Certificates and Coaching Permits

In accordance with Governor Ned Lamont's Executive Order 7C, I am writing to provide guidance regarding the extension of educator certificates and coaching permits for educators whose ability to meet statutory and regulatory requirements may be impacted during the COVID-19 pandemic.

Effective immediately, the Bureau of Educator Standards and Certification will extend the expiration date of *all Initial and Provisional Certificates (including Interim) and 5-Year Coaching Permits with expiration dates between 3/15/20 and 12/31/20 for 1-year from the date of original expiration.*

This extension does not apply to permits and/or authorizations such as 90-Day Certificates, Long Term Substitute Authorizations, Durational Shortage Area Permits (DSAP), Charter School Educator Permits and Emergency Coaching Permits, nor does it apply to Resident Educator Certificates. Educators currently serving under any of the aforementioned permits/authorizations will be able to seek renewal at the time of expiration in accordance with existing policy and procedures.

Educators may continue to renew Professional Educator Certificates online or by mail at no cost to the applicant, in accordance with existing policy and procedures. Additionally, 5-Year Coaching Permit holders are reminded it is their professional responsibility to maintain current First Aid and CPR certifications.

Over the coming weeks, the Bureau of Educator Standards and Certification will automatically update new expiration dates within the Connecticut Educator Certification System (CECS) and will print and mail new certificates to those educators impacted by the change.
