Providence Grove High School Groundbreaking

The Board set September 10 at 2:00 p.m. for Groundbreaking Ceremonies for Providence Grove High School.

N. C. High School Graduate Survey and High School Scholarship Totals

Kim Johnson, Director of High School Education, presented graduation statistical information for 2006. Student intention after graduation showed 337 students (35.5%) plan to attend public and/or private four-year colleges; 382 students (40.2%) plan to attend community colleges, private junior colleges, and trade schools. Students entering the military accounted for 3.6% of high school graduates and those entering the workforce accounted for 12.2% of high school graduates. The total monies awarded to Randolph County graduates toward furthering the education was \$7,274,381.00.

NCHSAA Academic Survey

Mrs. Johnson also reported that athletes accounted for 24% of the total high school population. The grade point average of athletes was 3.2 compared with 2.5 for non-athletes (on a scale of 4.0). Athletes averaged 5.6 days absent while non-athletes averaged 10.4 days absent per year. The dropout rate for athletes was .75% compared to 7.5% for non-athletes. The graduation rate for senior athletes was 98.67%. The rate for senior non-athletes was 92.15%
